AFTINET TPPA WORKERS RIGHTS LEAFLET ORDER FORM:

“Workers’ rights, not corporate rights”

The Australian government is negotiating a Trans-Pacific Partnership free trade agreement with the US, New Zealand, Chile, Peru, Brunei, Singapore, Malaysia and Vietnam.

The agenda is being set by giant US corporations. They have made public submissions saying they oppose commitments to workers’ rights in the agreement. And they want to use the negotiations to undermine local jobs and fair employment conditions for government contracts, to reduce policies for Australian content in film and television, and to charge higher prices for medicines. This US business agenda is about more rights for corporations, but less rights for workers, and less ability for governments to make laws in the public interest.

These social policies help make Australia a more equitable society than the US, with a distinctive culture. The leaflet argues that social policies which protect workers rights and the public interest should be maintained. They should be publicly debated here and decided by parliaments at the national or state level, not negotiated in a trade agreement.

The danger is that these policies will be traded off in exchange for access to US agricultural markets, which was not achieved in the AUSFTA back in 2004.
